Government Grants Available to Help with Training Costs

Anyone who is involved in managing a business or is a business owner understands the costs associated with health and safety training. The more the public and the government press business to be compliant with health and safety regulations here in Ontario the more financial burden it puts on companies. The Ontario government recognizes that the Ontario workforce is our greatest asset and employer involvement in training improves business performance. On March 28, 2014, Ontario signed the Canada-Ontario Job Fund Agreement with the federal government (Canada-Ontario Job Grant). The agreement is a key source of funding for new initiatives to help Ontario's employers develop their workforce through employer-led training. The job grant provides direct financial support to individual employers who wish to purchase training for their employees. It is available to small, medium and large businesses with a plan to deliver short-term training to existing and new employees, and will:

- Provide up to \$10,000 in government support per person for training costs.
- Require employers to contribute one-third of the total costs. There will be additional flexibility for small businesses to provide an in-kind contribution towards their share of the costs.
- Require training to be delivered by an eligible, third-party trainer.

International Day of Mourning April 28th

Please join us in recognizing the International Day of Mourning on April 28th. Approximately 2 1/2 million people worldwide die every year at work. Every year in Canada about 1,000 workers die from a work related injury or disease. Workers in Canada suffer from 250,000 work-related injuries or diseases associated with the work they do. Worldwide that figure is an astonishing 470 million workers.

On April 28, 1914 the first comprehensive workers compensation act was passed in the legislature. In 1984 the Canadian Labour Congress convention delegates adopted a resolution to create a remembrance day for workers killed or injured on the job. April 28th was the day they chose. In 1990 The government passed Bill C-223 The Workers Mourning Day Act.

"Throughout Canada, in each and every year, the 28th day of April shall be known under the name of Day of Mourning for Persons Killed or Injured in the Workplace."

The movement spread to the US in 1989, the UK in 1992 and by 1996 the International Labour Organization declared the International Day of Mourning. Today there are about 100 countries involved.

Join us in the international cry:

"Mourn the Dead and Fight for the Living."

Top Hazards

According to Health & Safety Ontario (www.healthandsafetyontario.ca) there are four main hazards that contribute to the majority of work related fatalities and injuries in Ontario. Musculoskeletal disorders will be the first hazard we will look at that makes up approximately 43% of all work-related injuries due to sprains, strains and injuries affecting muscles, tendons, ligaments and nerves. I'm sure we are all well aware of how easy it is to sustain an injury of this type. Next on the list is contact with machinery and the dangers associated with working in or around machinery. Common sense will dictate the dangers of working with some machinery and how one moment of not paying full attention can result in an injury or a fatality. When working in or around machinery we must always maintain and use the machinery in accordance with the manufacturer's instructions. Slips and falls are also a major contributor to the top four hazards with approximately 80 workers injured every day—that is one every 20 minutes. This is why it is so important that we are compliant and that we use the protective equipment required to do the job safely. Last but certainly not least the greatest single cause of all Ontario worker fatalities is motor vehicle collisions on Ontario roads. Be aware of all the hazards and stay safe.

Just keep in mind with the warmer weather our children are spending more time out doors so please pay attention and slow down while driving in school and park zones, and on residential streets. If we all look out for one another we can all have a safe and happy spring.
